**Confirmation of registration of waste exemptions**

We can confirm that we have registered the operation(s) listed on the attached schedule, as exempt under Environmental Permitting (England and Wales) Regulations 2016, at the site shown.

The exemption(s) will remain valid at this site until 20/09/2026.

The details of your registration will appear on the public register on our website [Check for a permit, licence or exemption](#).

Your exemptions are valid only whilst you operate within the conditions. If you cannot operate within the conditions of your exemptions, you must stop operating and apply for an environmental permit.

We may periodically inspect your activities to ensure you are operating within the exemption conditions.

**Offences**

**Any non-compliance with the exemption criteria is an offence which renders the exemption invalid, and the activity is no longer exempt. We will de-register your exemption, by removing it from the register, and will consider taking enforcement action against you.**

It is a criminal offence to carry out these types of operation without the correct exemption, and an offence to operate outside the conditions of the exemption. It is your responsibility to ensure that you know what the legislation requires and that you operate within it.

Besides any enforcement action that may be taken by NRW, certain disposals of waste in or on land (including burning) could also be taxed at the unauthorised rate of Landfill Disposals Tax. The Welsh Revenue Authority collects and manages the tax; find out more: [www.gov.wales/wra](http://www.gov.wales/wra). Under Section 60 of the Landfill Disposal Tax (Wales) Act 2017, Natural Resources Wales may share information with WRA to assist in the collection and management of this tax.

**You must ensure that you understand your responsibilities under any other relevant legislation before carrying out any exempt operations.**

Registering an exemption only addresses the waste aspects of an activity as required by the Environmental Permitting Regulations.

Compliance with the exemption conditions does not remove your obligation to comply with any other legislative provision which may apply, for example flood risk activity permits or planning permission.

You must use registered waste carriers and comply with duty of care for any movements of waste. Find out more here: [Register or renew as a waste carrier, broker or dealer](#)

You must make sure your activities do not endanger human health or the environment. You must not:

- cause a risk to water, air, soil, plants or animals
- cause a nuisance through noise or odours
- adversely affect the countryside or places of special interest

Places of special interest include, but are not limited to:

- European sites (Special Areas of Conservation and Special Protection Areas)
- Ramsar sites
- Sites of Special Scientific Interest
- National and local nature reserves
- Areas of Outstanding Natural Beauty
- Marine Conservation Zones
- national parks

Registering an exemption for activities within an area that is also a Site of Special Scientific Interest (SSSI) does not also give you consent to undertake any of that site's notified list of operations likely to damage the special interest. You must give separate notice to Natural Resources Wales for any activities within a SSSI to ensure you are compliant with the requirements of the Wildlife and Countryside Act 1981. **De-registration**


